MADE BY THE PRESIDENT UNDER SECTION 29 OF THE PETROLEUM ACT

THE PETROLEUM WHOLESALE MARKETING (COMPETITIVE
BIDDING) (AMENDMENT) REGULATIONS, 1998

1. These Regulations may be cited as the Petroleum Wholesale Marketing (Competitive Bidding) (Amendment) Regulations, 1998. Citation
2. In these Regulations “the Regulations” means The Petroleum Wholesale Marketing (Competitive Bidding) Regulations, 1998. Interpretation

3. Regulation 2 of the Regulations is amended in the definition of “wholesale marketing”, by inserting immediately before the word “refining” the word “licensed”. Regulation 2
amended
4. Regulation 3 of the Regulations is amended— Regulation 3
amended
 - (a) by deleting the words “and when”; and
 - (b) by deleting the word “or”.
5. Regulation 4 of the Regulations is amended— Regulation 4
amended
 - (a) by deleting the word “one” and substituting the word “two”; and
 - (b) by deleting the word “newspaper” and substituting the word “newspapers”.
6. Regulation 5 of the Regulations is amended by deleting the words “c/o The Permanent Secretary”. Regulation 5
amended
7. Regulation 9 (g) of the Regulations is amended by deleting the comma after the word “safely” and substituting therefor a semicolon and by deleting all of the words appearing thereafter. Regulation 9
amended
8. Regulation 13 of the Regulations is amended— Regulation 13
amended
 - (a) by deleting the word “one” and substituting the word “two”; and
 - (b) by deleting the word “newspaper” and substituting the word “newspapers”.

amended

9. Regulation 16 of the Regulations is amended—
- (a) by deleting subregulation (b) and substituting the following—
 - “(b) transport liquid petroleum fuels by his own or rented means provided that the vehicles or vessels used for such transportation conform to the Petroleum Act and any other written laws;”;
 - (b) in subregulation (e) by deleting the word “approved” and the words “and installations”.
