ORDER

MADE BY THE MINISTER OF ENERGY AND ENERGY INDUSTRIES UNDER SECTION 31 OF THE PETROLEUM ACT

THE PRICE OF PETROLEUM PRODUCTS (AMENDMENT) ORDER, 1995

1. This Order may be cited as the Price of Petroleum Products Citation (Amendment) Order, 1995.

2. The First Schedule to the Price of Petroleum Products Order is amended—
