THE PRICE OF PETROLEUM PRODUCTS (AMENDMENT)
ORDER, 1992

1. This Order may be cited as the Price of Petroleum Products short title (Amendment) Order, 1992.

2. The First Schedule to the Price of Petroleum Products Order is amended—

- (d) in paragraph 3(1)(b) by substituting for the words "39.0 cents per litre" occurring in the second line thereof the words "85.0 cents per litre".
