MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 44F(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ORDINANCE

THE CHRISTMAS RACE MEETING (TEMPORARY PROVISIONS)
ORDER, 1971

1. This Order may be cited as the Christmas Race Meeting (Temporary Citation Provisions) Order, 1971.
2. This Order shall come into operation at 10.30 a.m. on each of the undermentioned dates and shall cease at 8.00 p.m. on each of the said dates:—

Monday, 27th December, 1971	
Saturday, 1st January, 1972	
Saturday, 8th January, 1972	
Thursday, 13th January, 1972	
Saturday, 15th January, 1972.	
3. Notwithstanding any other enactment to the contrary no person shall park or cause or permit any vehicles to be parked or to remain on any of the roads mentioned below at the times shown in paragraph 2:—

(a) Queen's Park West between Cipriani Boulevard and Queen's Park East (except for the Taxi Stand);	Parking prohibition on certain roads
(b) Chancery Lane between Albion Street and Queen's Park West;	
(c) Dere Street;	
(d) Albion Street;	
(e) Maraval Road between Hayes Street and St. Clair Circle.	
4. During the times shown below and dates shown in paragraph 2 vehicular traffic will proceed in the direction indicated below:—

(a) Chancery Lane between Queen's Park West and Albion Street in a northerly direction from 10.30 a.m. to 6.00 p.m.;	One-way traffic
(b) Chancery Lane between Queen's Park West and Albion Street in a southerly direction from 6.00 p.m. to 8.00 p.m.	
5. (1) Motorists parking their vehicles in the Queen's Park Savannah shall do so as directed by the Police on duty.
