THE PHARMACY BOARD (AMENDMENT) REGULATIONS, 2004

1. These Regulations may be cited as the Pharmacy Board Citation  
(Amendment) Regulations, 2004.

2. The Pharmacy Board (Amendment) Regulations, 1990 are Legal Notice  
amended by substituting for the Second Schedule the following: No. 2 of 1990
