THE AID TO PIONEER INDUSTRIES (GIBBONS FEEDS (WEST INDIES) LIMITED) (STOCK AND POULTRY FEEDS) ORDER, 1959.

1. This Order may be cited as the Aid to Pioneer Industries (Gibbons Feeds (West Indies) Limited) (Stock and Poultry Feeds) Order, 1959.

2. Gibbons Feeds (West Indies) Limited, a company registered under the Companies Ordinance, Ch. 31. No. 1 is hereby declared to be a pioneer manufacturer for the purposes of the Aid to Pioneer Industries Ordinance, in relation to its pioneer factory situate at 53, Long Circular Road, Port-of-Spain, and to the manufacture of balanced stock and poultry feeds and the preparation of ingredients for such feeds (by the Aid to Pioneer Industries (Stock and Poultry Feeds) Order, 1950, declared to be a pioneer industry) with effect from the 22nd day of November, 1958, and the production day of the said factory is hereby declared to be the 2nd day of January, 1959.

BYE-LAWS

MADE BY THE GOVERNOR IN COUNCIL UNDER SECTION 22 OF THE PORT
SERVICES (DUES, CHARGES AND MANAGEMENT) ORDINANCE

THE COASTAL STEAMERS (CHARGES FOR SERVICES)
(AMENDMENT) BYE-LAWS, 1958.

1. These Bye-Laws may be cited as the Coastal Steamers (Charges for Services) (Amendment) Bye-laws, 1958, and shall be read as one with the Coastal Steamers (Charges for Services) Bye-laws, 1955, hereinafter referred to as the Principal Bye-laws.

2. Schedule A to the Principal Bye-laws is hereby amended in respect of the Head "Groceries and Dry Goods" as follows:—

(a) by substituting for the item—"Onions, Garlic and Irish Potatoes in packages not exceeding 160 lb.25"

occurring therein, the following:—

"Onions, Garlic and Irish Potatoes in packages not exceeding 100 lb.25"

(b) by substituting for the item—"Rice, in bags of 160 lb.45"

occurring therein, the following:—

"Rice in bags not exceeding 140 lb.28"

"Rice in bags not exceeding 180 lb.45"

"Rice in bags exceeding 180 lb.60"

THE LEGISLATIVE COUNCIL OF TRINIDAD AND TOBAGO

RESOLUTION

CONFERMENT OF CRIMINAL JURISDICTION ON THE FEDERAL SUPREME COURT

WHEREAS it is provided by paragraph (2) of Article 83 of the Constitution of the West Indies that where a superior court of a Territory has jurisdiction to hear and determine appeals in criminal matters from another superior court of that Territory, then any law of the Federal Legislature that confers on the Federal Supreme Court jurisdiction to hear and determine appeals in criminal matters from that other superior court shall, to the extent that it confers that jurisdiction, not have effect unless and until the Governor of

that Territory has given notice that the legislative chamber of that Territory has, by resolution, approved the conferment of that jurisdiction:

And whereas Part III of the Federal Supreme Court Regulations, 1958, confers on the Federal Supreme Court jurisdiction to hear and determine appeals in criminal matters from the Supreme Court of Trinidad and Tobago;

And whereas it is expedient that Part III of the Federal Supreme Court Regulations, 1958, should have effect:

Now, therefore, be it resolved and it is hereby resolved that the Legislative Council of Trinidad and Tobago approves the conferment on the Federal Supreme Court of jurisdiction to hear and determine appeals in criminal matters from the Supreme Court of Trinidad and Tobago.
