ORDER

MADE BY THE TRANSPORT BOARD UNDER SUBSECTION (8) OF SECTION 44 OF THE MOTOR VEHICLES AND ROAD TRAFFIC ORDINANCE AS ENACTED BY THE MOTOR VEHICLES AND ROAD TRAFFIC (AMENDMENT) ORDINANCE, 1956

THE SPEED LIMITS (BUILT-UP AREAS) ORDER, 1966

1. This Order may be cited as the Speed Limits (Built-up Areas) Order, 1966.
