THE ELECTION (AMENDMENT) RULES, 2007

1. These Rules may be cited as the Election (Amendment) Rules, Citation 2007.
2. In these rules “the Rules” means the Election Rules made under section 161(1) of the Representation of the People Act. Interpretation

3. Rule 2 of the Rules is amended by inserting in the appropriate alphabetical sequence the following definition: Rule 2
amended

“special ballot paper” means a ballot paper issued to a special elector under rule 66;”.
4. Rule 23(1) of the Rules is amended by inserting after the words “every ballot paper,” the words “and printed on every special ballot paper”. Rule 23
amended
5. Rule 65(a) and (b) and 66(1) of the Rules are amended by inserting before the words “ballot papers” the word “special”. Rules 65(a)
and (b) and
66(1) amended
6. Rule 66(2) of the Rules is amended by inserting before the words “ballot paper” the word “special”. Rule 66(2)
amended
7. Rule 67 of the Rules is amended in the last line in that rule by inserting after the words “on the issue” the words “or opening” and by inserting before the words “ballot papers” the word “special”. Rule 67
amended
8. Rule 68(1) of the Rules is amended by deleting the words “on the issue of” and substituting in its place the words “on the issue or the opening of special”. Rule 68(1)
amended
9. Rules 73(2) and 74 of the Rules are amended by inserting before the words “ballot papers” the word “special”. Rules 73(2)
and 74
amended
10. Rule 82(c)(i) of the Rules is amended by inserting before the words “ballot paper” the word “special”. Rule 82(c)(i)
amended

11. Rule 90 of the Rules is amended by inserting before the words “ballot paper” wherever those words occur in that rule the word “special”.

Rule 101

12. Rule 101 of the Rules is amended—

(a) in the subrule (1), by inserting after the words “of the Poll” the words “and shall add thereto the count of the special ballot”; and

(b) in the subrule (9), by inserting after the words “Statement of the Poll” the words “and the count of the special ballots”.

Rule 108
amended

13. Rule 108(6) of the Rules is amended—

(a) in paragraph (a), by inserting after the words “by polling divisions” the words “and by special ballot”; and

(b) in paragraph (b), by inserting after the words “number of rejected” the word “special”.
