NOTICE

ISSUED BY THE MINISTER FOR LEGAL AFFAIRS UNDER PARAGRAPH 6 OF THE SECOND SCHEDULE TO THE LAW REVISION ACT, 1979

NOTICE is hereby given that the Minister approves that, in the first revision of the Laws under the Law Revision Act, 1979, the Law Revision Commission may, by virtue of the powers conferred on it by section 23 of, and paragraph 6 of the Second Schedule to, the Law Revision Act, 1979—

- (a) amend (in accordance with subparagraph (a) of the said paragraph 6) the written laws set out in the first column of the First Schedule in the manner specified in the second column of the said Schedule; and
- (b) delete (in accordance with subparagraph (b) of the said paragraph 6) any reference to "warden" in the statutory provisions specified in the Second Schedule.
