CONSENT TO PURCHASE ENERGY FROM AN APPROVED  
GENERATOR OF ELECTRICITY

CONSENT GIVEN BY THE MINISTER OF PUBLIC UTILITIES TO THE TRINIDAD  
AND TOBAGO ELECTRICITY COMMISSION UNDER SECTION 31(2)(AC) OF  
THE TRINIDAD AND TOBAGO ELECTRICITY COMMISSION ACT,  
CHAP. 54:70

WHEREAS it is provided by section 31(2)(ac) of the Trinidad and Tobago  
Electricity Commission Act, Chap. 54:70 (hereinafter referred to as "the  
Act") that the Trinidad and Tobago Electricity Commission (hereinafter  
referred to as "the Commission") may, with the consent of the Minister,  
purchase energy from an approved generator of electricity:

And whereas InnCogen, Limited (hereinafter referred to as  
"InnCogen") was declared to be an approved generator of electricity by the  
Trinidad and Tobago Electricity Commission (Declaration of Approved  
Generator of Electricity) Order, 1998, made by the Commission with the  
approval of the Minister under section 31(3c) of the Act:

Now, therefore, the Minister of Public Utilities hereby consents to the  
purchase of energy by the Commission from InnCogen.

APPROVAL OF AND CONSENT TO THE RIGHT OF AN APPROVED  
GENERATOR OF ELECTRICITY TO GENERATE ENERGY

APPROVAL AND CONSENT GIVEN BY THE MINISTER OF PUBLIC UTILITIES TO  
INNCOGEN, LIMITED UNDER SECTION 31(5) OF THE TRINIDAD AND  
TOBAGO ELECTRICITY COMMISSION ACT, CHAP. 54:70

WHEREAS it is provided by section 31(5) of the Trinidad and Tobago  
Electricity Commission Act, Chap. 54:70 (hereinafter referred to as “the  
Act”) that the right of an approved generator of electricity to generate  
energy is subject to such terms and conditions as the Minister may  
determine:

And whereas InnCogen, Limited (hereinafter referred to as  
“InnCogen”) was declared to be an approved generator of electricity by the  
Trinidad and Tobago Electricity Commission (Declaration of Approved  
Generator of Electricity) Order, 1998, made by the Trinidad and Tobago  
Electricity Commission (hereinafter referred to as “the Commission”) with  
the approval of the Minister under section 31(3C) of the Act:

And whereas the Commission and InnCogen propose to enter into a  
Power Purchase Agreement wherein the Commission will grant to  
InnCogen a licence permitting InnCogen as an approved generator of  
electricity the non exclusive right to generate electricity for all purposes of  
the said Power Purchase Agreement upon the terms and subject to the  
conditions therein contained:

Now, therefore, the Minister of Public Utilities hereby approves of and  
consents to the right of InnCogen to generate energy in accordance with  
and subject to the terms and conditions of the said Power Purchase  
Agreement.
