RULES OF COURT

MADE BY THE RULES COMMITTEE UNDER SECTION 77 OF THE
SUPREME COURT OF JUDICATURE ACT, 1962

THE SUPREME COURT (AMENDMENT) RULES, 1981

1. These Rules may be cited as the Supreme Court (Amendment) Rules, 1981, and shall be read as one with the Rules of the Supreme Court, 1975. Citation

2. Order 4 is amended—

Order 4
amended

(a) in the caption to rule 2, by substituting the words "a Sub-Registry" for the words "Sub-Registry of San Fernando";

(b) in rule 2(1) and (3), by substituting the words "a Sub-Registry" for the words "the Sub-Registry of San Fernando" wherever the latter words occur;

(c) by substituting for rule 3 and the caption thereto the following:—

"Commencement of Proceedings in the Sub-Registry of Tobago—

3. Proceedings shall be commenced in the Sub-Registry of Tobago when—

(a) the subject matter of the proceedings is land situate in Tobago; or

(b) the cause of action arose in Tobago.";

(d) by revoking rule 4 and by renumbering rules 5 to 8 as rules 4 to 7 respectively;

(e) by substituting for the renumbered rule 4 and the caption thereto the following—

"Parties Address for Service on Removal of a Cause or Matter

4. Where under the preceding rules a cause or matter is removed from the Registry or a Sub-Registry the plaintiff and the defendant shall, within seven days of such removal, give notice to the defendant and the plaintiff respectively of an address for service in the Sub-Registry or the Registry (as the case may be) to which the cause or matter is removed, in all respects as if the proceedings had been begun and the appearance had been originally entered in that Sub-Registry or the Registry (as the case may be).";

(f) in rule 7 (as renumbered), by substituting the words "rule 2(2) or 2(3)" for the words "rule 2(2), 2(3) or 3(4)."

3. Order 12 rule 2(3) is amended by deleting the words "or the Registry".

Order 13
amended

4. Order 13 is amended by revoking rule 8 and by renumbering rule 9 as rule 8.

Order 63
amended

5. Order 63 rule 8(1) is amended by substituting the words "Order 4 rule 2(2) and 2(3)" for the words "Order 4 rules 2(2), 2(3), 3(2), 3(3) and 3(4)".

6. These Rules shall come into operation on the first day of June, 1981.
