UNDER SECTION 15 OF THE TRINIDAD AND TOBAGO FREE ZONES ACT

THE TRINIDAD AND TOBAGO FREE ZONES (NO. 5) ORDER, 1993

1. This Order may be cited as the Trinidad and Tobago Free Zones (No. 5) Order, 1993. Citation

2. In this Order—

“the Company” means the Trinidad and Tobago Free Zones Company Limited, a limited liability company incorporated under the Companies Ordinance the shares in which shall be vested directly or indirectly in the Corporation Sole established by the Minister of Finance (Incorporation) Act;

“the Free Zone” means the Free Zone comprising 17.7099 hectares situate in the Ward of Couva in the County of Caroni in the Island of Trinidad and more particularly described on the Survey Plan made under Survey Order No. 30 of 1993 dated 2nd February, 1993;

“the Point Lisas Free Zone” means the area specified in the Second Schedule of the Act.

3. The Company grants approval to Nucor Iron Carbide, Inc., a corporation organized and existing under the Laws of the State of Delaware in the United States of America and registered under the Companies Ordinance with a branch at No. 36 Pembroke Street in the City of Port-of-Spain in the Island of Trinidad (hereinafter called “Nucor”) as an approved enterprise to undertake the approved activity of the manufacture of iron carbide at the Free Zone and, during the construction phase of Nucor’s Plant at the Free Zone and until such Plant is fully operational at the Free Zone, to import into the Point Lisas Free Zone free of customs duty and to store at the Point Lisas Free Zone all capital goods, spare parts and machinery, consumer goods, raw materials, components and articles intended to be used for the purposes of construction, alteration, reconstruction, extension and repair of the infrastructure of any premises situate within the Free Zone and including the equipping of such premises in relation to the approved activity at the Free Zone and the Point Lisas Free Zone, subject to the payment of annual fees by Nucor to the Company, pursuant to the terms of an agreement between Nucor and the Company made as of the 15th day of April, 1993.

4. This Order is deemed to have come into effect on the 26th day of March, 1993. Commencement
