MADE BY THE MINISTER AFTER CONSULTATION WITH THE MINISTER WITH RESPONSIBILITY FOR PLANNING AND DEVELOPMENT UNDER SECTION 3 OF THE TRINIDAD AND TOBAGO FREE ZONES ACT

THE TRINIDAD AND TOBAGO FREE ZONES (POINT LISAS INDUSTRIAL PORT DEVELOPMENT CORPORATION LIMITED) (NO. 7) ORDER, 1995

1. This Order may be cited as the Trinidad and Tobago Free Zones Citation (Point Lisas Industrial Port Development Corporation Limited) (No. 7) Order, 1995.

2. The areas situated in the Point Lisas Industrial Estate, Ward of Free Zones Couva in the County of Caroni and owned by the Point Lisas Industrial declared Development Corporation Limited (hereinafter called “the company”) and described in the First and Second Schedules are hereby declared First and Second free zones. 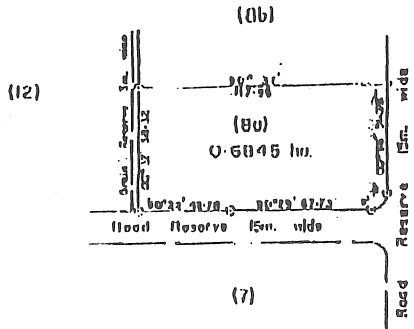
