UNDER SECTION 15(2) OF THE TRINIDAD AND TOBAGO FREE ZONES
ACT

THE TRINIDAD AND TOBAGO FREE ZONES (NO. 2)
ORDER, 2005

1. This Order may be cited as the Trinidad and Tobago Free Zones ^{Citation}
(No. 2) Order, 2005.

2. In this Order—

“the Company” means the Trinidad and Tobago Free Zones <sup>Interpreta-
tion</sup>
Company Limited; and

“the Free Zones” mean the designated Free Zones the FIRST
THEREOF comprising zero point eight eight six eight
hectares (0.8868 ha.), the SECOND THEREOF
comprising one thousand three hundred and eighty-nine
point two square metres (1,389.2 m²), the THIRD
THEREOF comprising one thousand three hundred and
eighty-eight point one square metres (1,388.1 m²), the
FOURTH THEREOF comprising four hundred and
seventy-two point two square metres (472.2 m²), the
FIFTH THEREOF comprising four hundred and fifty
point three square metres (450.3 m²), together being
portion of a larger parcel of land comprising 99 acres
0 roods and 12 perches more or less, described in Deed
registered as No. 2767 of 1909, which said parcels of land
with appurtenances thereon are more particularly
described and coloured green and marked 0.8868
hectares, tank 70, tank 20, tank 43 and tank 42 on the
plan of survey dated the 10th day of August, 2005,
prepared by Shri Persad Maharaj, Licensed Land
Surveyor.

3. (1) The Company grants approval to Trinidad Bulk Traders <sup>Grant of
Approval</sup>
Limited as an approved enterprise, to undertake the activity of the
manufacture of fuel grade dehydrated ethanol and storage related
thereto in the Free Zones, as from the 30th day of September, 2005.

(2) The approval under subsection (1) shall be subject to the condition that Trinidad Bulk Traders Limited shall comply with the terms and conditions of the agreement made between Trinidad Bulk Traders Limited and the Company with respect to—

- (a) the payment of annual fees to the Company;
- (b) the provision of security; and
- (c) other requirements for operation by Trinidad Bulk Traders Limited in the Free Zones.
