THE SANTA ROSA RACING (TEMPORARY PROVISIONS)
ORDER, 1994

1. This Order may be cited as the Santa Rosa Racing (Temporary citation Provisions) Order, 1994.

2. This Order comes into operation at 11.00 a.m. and ceases at 7.00 p.m. on each of the following days: Commencement and cessation

3. No person shall park or cause or permit any vehicle to be parked or to remain on any of the following roads:

- (a) O'Meara Road;
- (b) O'Meara Ferry Road, between Churchill-Roosevelt Highway and a point 200 yards South of the eastern entrance to the Santa Rosa Racing Facility;
- (c) Churchill-Roosevelt Highway, between O'Meara Ferry Road and the western exit of the Santa Rosa Racing Facility;
- (d) the roads leading to and from the Santa Rosa Racing Facility buildings.

Vehicular

4. Between the hours of 11.00 a.m. and 6.00 p.m., vehicular traffic shall enter the Santa Rosa Racing Facility by way of the eastern entrance on O'Meara Ferry Road and shall leave either by way of the north-western exit or at the point of entry, in accordance with the direction of Police Officers on duty.

5. Vehicles shall be parked in the Santa Rosa Racing Facility in accordance with the directions of Police Officers on duty.

6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
