MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(INTERNATIONAL EXPOSITION '94) ORDER, 1994

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (International Exposition '94) Order, 1994.

2. This Order has effect on:

- (a) Friday, 15th April, 1994 from 4.00 p.m. to 1.00 a.m. on Saturday, 16th April, 1994;
- (b) Saturday, 16th April, 1994 from 10.00 a.m. to 1.00 a.m. on Sunday, 17th April, 1994;
- (c) Sunday, 17th April, 1994 from 10.00 a.m. to 1.00 a.m. on Monday, 18th April, 1994;
- (d) Monday, 18th April, 1994 from 9.00 a.m. to 12.00 midnight;
- (e) Tuesday, 19th April, 1994 from 9.00 a.m. to 12.00 midnight;
- (f) Wednesday, 20th April, 1994 from 9.00 a.m. to 12.00 midnight;
- (g) Thursday, 21st April, 1994 from 9.00 a.m. to 12.00 midnight;
- (h) Friday, 22nd April, 1994 from 10.00 a.m. to 1.00 a.m. on Saturday, 23rd April, 1994;
- (i) Saturday, 23rd April, 1994 from 10.00 a.m. to 1.00 a.m. on Sunday, 24th April, 1994; and
- (j) Sunday, 24th April, 1994 from 10.00 a.m. to 12.00 midnight.

3. Parking is prohibited on the following roads:

- (a) Audrey Jeffers Highway from Wrightson Road to Mucurapo Link Road;
- (b) Fitzblackman Drive;
- (c) Wrightson Road Extension;
- (d) Maraval Parkway;
- (e) Mucurapo Link Road;
- (f) Hamilton Holder Street;
- (g) Hamilton Holder Street Extension;
- (h) Dennis Mahabir Street;
- (i) De Verteuil Street;
- (j) Petra Street;
- (k) Ana Street;
- (l) Belle Smythe Street;
- (m) Ariapita Avenue, between Maraval Parkway and Gallus Street; and
- (n) Wrightson Road between Gallus Street and Hamilton Holder Street Extension.

4. Parking is restricted to the eastern side of the following roads:

(a) O'Connor Street;

(b) Taylor Street.

One-way

5. Vehicular traffic shall proceed as follows:

(a) on Wrightson Road Extension, between Fitzblackman Drive and Ana Street in an easterly direction only;

(b) on Fitzblackman Drive, between Maraval Parkway and Wrightson Road Extension—

(i) before and during the show in a southerly direction only;

(ii) after the show in a northerly direction only;

No right turn

6. Vehicular traffic proceeding South along Dennis Mahabir Street, shall not turn right into Wrightson Road Extension.

7. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
