PROVISIONAL COLLECTION OF TAXES ACT

THE PROVISIONAL COLLECTION OF TAXES ORDER, 2006

1. This Order may be cited as the Provisional Collection of Taxes Citation
Order, 2006.

2. The Miscellaneous Taxes Act is amended— Chap. 77:01
