Act No. 42 of 1977

AN ACT to provide for the Supplementary Appropriation
for the service of Trinidad and Tobago for the year
ending on the 31st day of December, 1977.

[Assented to 27th October, 1977]

ENACTED by the Parliament of Trinidad and Tobago as Enactment
follows:—

1. This Act may be cited as the Supplementary Short title
Appropriation (No. 2) Act, 1977.

Further issue of three hundred and twelve million, five hundred and seventy-five thousand, four hundred and seventy-nine dollars from the Consolidated Fund authorised

2. A further issue from the Consolidated Fund of the sum of three hundred and twelve million, five hundred and seventy-five thousand, four hundred and seventy-nine dollars is hereby authorised for meeting expenditure for the service of the year ending 31st December, 1977, under the Heads of Expenditure specified in the Schedule; and the sum specified in the said Schedule opposite a Head is hereby appropriated out of the said three hundred and twelve million, five hundred and seventy-five thousand, four hundred and seventy-nine dollars for the purpose specified in relation to that Head in the Supplementary Estimates for 1977.
