TRINIDAD AND TOBAGO

**Act No. 12 of 1964**

[L.S.]

AN ACT to provide for Supplementary Appropriation for the service of Trinidad and Tobago for the year ending on the 31st day of December, 1964.

*[Assented to 13th June, 1964.]*

BE IT ENACTED by the Queen's Most Excellent Majesty, Enactment by and with the advice and consent of the Senate and House of Representatives of Trinidad and Tobago, and by the authority of the same as follows :

1. This Act may be cited as the Supplementary Appropriation Act, 1964. Short title

2. A further sum not exceeding nine million, four hundred and eleven thousand, six hundred and sixty-three dollars shall be and the same is hereby charged upon the Consolidated Fund for the service of the year ending on the 31st day of December, 1964.

3. The further sum charged by section 2 is hereby appropriated to the services and for the purposes expressed in the Schedule and shall be deemed to have been so appropriated from the 1st day of January, 1964.
