ORDER

MADE BY THE PRESIDENT UNDER SECTION 5(3) OF THE
LAND ACQUISITION ACT

THE LAND ACQUISITION (DECLARATION OF ACQUISITION)
(NO. 5) ORDER, 2005

1. This Order may be cited as the Land Acquisition (Declaration of Acquisition) (No. 5) Order, 2005.

2. Five parcels of land—

Declaration of
acquisition

- (a) together containing 0.8184 hectares more or less, situate between Kunjal Road and Cumuto Road, Barrackpore, in the Ward of Moruga, in the County of Victoria;
- (b) described in the Schedule and coloured raw sienna on a plan of survey signed by the Director of Surveys and dated 11th February, 2000, executed under Survey Order No. 138/96 and filed in the Lands and Surveys Division; and
- (c) having been declared by the President by Order, by Legal Notice No. 145 of 2005 as land required for a public purpose and approved for such purpose by the Parliament of the Republic of Trinidad and Tobago by Resolution of the House of Representatives on 21st October, 2005 and the Senate on 8th November, 2005, have been acquired for the following purpose: The laying of the Natural Gas Pipelines for the development of the natural gas industry of Trinidad and Tobago.

SCHEDULE

Five parcels of land together containing 0.8184 hectares more or less, situate between Kunjal Road and Cumuto Road, Barrackpore, in the Ward of Moruga, in the County of Victoria, and further described as follows:

- (1) a parcel of land comprising 0.3243 hectares more or less, said to belong now or formerly to Spar Investment Limited;
- (2) a parcel of land comprising 0.1203 hectares more or less, said to belong now or formerly to Latchmidath Ramkissoon;

- (3) a parcel of land comprising 0.1005 hectares more or less, said to belong now or formerly to Kaloutie Ramadhin Bissessar and Mathura Bissessar;
- (4) a parcel of land comprising 0.1542 hectares more or less, said to belong now or formerly to Basdeo Siew Sankar;
- (5) a parcel of land comprising 0.1191 hectares more or less, said to belong now or formerly to Deodath Heera and others.

These parcels are more particularly shown coloured raw sienna on a Survey Plan filed as AN181/21 in the Vault of the Lands and Surveys Department, Old General Post Office Building, Wrightson Road, Port-of-Spain.
