(NO. 16) ORDER, 2005

Citation            1. This Order may be cited as the Land Acquisition (Declaration of Acquisition) (No. 16) Order, 2005.

Declaration of  
acquisition

2. Eight parcels of land—

- (a) together containing 2.4126 hectares more or less, situate between Grant Trace, Rousillac and Mondesir-Delhi Road, Fyzabad, in the Wards of La Brea and Siparia, in the County of St. Patrick;
- (b) described in the Schedule and coloured raw sienna on a plan of survey signed by the Director of Surveys and dated 26th September, 2000, executed under Survey Order No. 138/96 and filed in the Lands and Surveys Division; and
- (c) having been declared by the President by Order, by Legal Notice No. 156 of 2005 as land required for a public purpose and approved for such purpose by the Parliament of the Republic of Trinidad and Tobago by Resolution of the House of Representatives on 21st October, 2005 and the Senate on 8th November, 2005, have been acquired for the following purpose: The laying of the Natural Gas Pipelines for the development of the natural gas industry of Trinidad and Tobago.

## SCHEDULE

Eight parcels of land together containing 2.4126 hectares more or less, situate between Grant Trace, Rousillac and Mondesir-Delhi Road, Fyzabad, in the Wards of La Brea and Siparia, in the County of St. Patrick, and further described as follows:

- (1) a parcel of land comprising 0.5923 hectares more or less, said to belong now or formerly to Randolph Cayenne;
- (2) a parcel of land comprising 0.3438 hectares more or less, said to belong now or formerly to Vada Cheddie and others;

- (3) a parcel of land comprising 0.0789 hectares more or less, said to belong now or formerly to Siew Sooknanan and others;
- (4) a parcel of land comprising 0.3630 hectares more or less, said to belong now or formerly to Boodoo Payman;
- (5) a parcel of land comprising 0.0047 hectares more or less, said to belong now or formerly to Clifton Chankersingh and others;
- (6) a parcel of land comprising 0.2443 hectares more or less, said to belong now or formerly to Sumitra Chankersingh a/c Pargass and others;
- (7) a parcel of land comprising 0.6067 hectares more or less, said to belong now or formerly to Roopnarine Seenath and Deonarine Seenath;
- (8) a parcel of land comprising 0.1789 hectares more or less, said to belong now or formerly to Ramragee.

These parcels are more particularly shown coloured raw sienna on a Survey Plan filed as AN181/36 in the Vault of the Lands and Surveys Department, Old General Post Office Building, Wrightson Road, Port-of-Spain.
