## ORDER

MADE BY THE PRESIDENT UNDER SECTION 5(3) OF THE  
LAND ACQUISITION ACTTHE LAND ACQUISITION (DECLARATION OF ACQUISITION)  
(NO. 26) ORDER, 2005

Citation            1. This Order may be cited as the Land Acquisition (Declaration of Acquisition) (No. 26) Order, 2005.

Declaration of acquisition    2. Nine parcels of land—

(a) together containing 3.3380 hectares more or less, situate at Forres Park Estate, Claxton Bay, in the Wards of Couva and Pointe-a-Pierre, in the Counties of Victoria and Caroni;

(b) described in the Schedule and coloured raw sienna on a plan of survey signed by the Director of Surveys and dated 10th April, 2001, executed under Survey Order No. 138/96 and filed in the Lands and Surveys Division; and

(c) having been declared by the President by Order, by Legal Notice No. 166 of 2005 as land required for a public purpose and approved for such purpose by the Parliament of the Republic of Trinidad and Tobago by Resolution of the House of Representatives on 21st October, 2005 and the Senate on 8th November, 2005, have been acquired for the following purpose: The laying of the Natural Gas Pipelines for the development of the natural gas industry of Trinidad and Tobago.

## SCHEDULE

Nine parcels of land together containing 3.3380 hectares more or less, situate at Forres Park Estate, Claxton Bay, in the Wards of Couva and Pointe-a-Pierre, in the Counties of Victoria and Caroni, and further described as follows:

- (1) seven parcels of land comprising together 3.1376 hectares more or less, said to belong now or formerly to Caroni (1975) Ltd.;
- (2) a parcel of land comprising 0.1173 hectares more or less, said to belong now or formerly to Deo Mahadeo, Linda Sammy and others;

- (3) a parcel of land comprising 0.0831 hectares more or less, said to belong now or formerly to Jered Bahadur, Stella Lily Bahadur and others.

These parcels are more particularly shown coloured raw sienna on a Survey Plan filed as AN181/53 in the Vault of the Lands and Surveys Department, Old General Post Office Building, Wrightson Road, Port-of-Spain.
