MADE BY THE PRESIDENT UNDER SECTION 5(3) OF THE
LAND ACQUISITION ACTTHE LAND ACQUISITION (DECLARATION OF ACQUISITION)
(NO. 29) ORDER, 2005

Citation 1. This Order may be cited as the Land Acquisition (Declaration of Acquisition) (No. 29) Order, 2005.

Declaration of acquisition 2. Twenty-seven parcels of land—

- (a) together containing 4.9238 hectares more or less, situate between Siparia Old Road and Ramnath Trace, San Francique, in the Ward of Siparia, in the County of St. Patrick;
- (b) described in the Schedule and coloured raw sienna on a plan of survey signed by the Director of Surveys and dated 26th February, 2002, executed under Survey Order No. 203/2000 and filed in the Lands and Surveys Division; and
- (c) having been declared by the President by Order, by Legal Notice No. 169 of 2005 as land required for a public purpose and approved for such purpose by the Parliament of the Republic of Trinidad and Tobago by Resolution of the House of Representatives on 21st October, 2005 and the Senate on 8th November, 2005, have been acquired for the following purpose: The laying of the Natural Gas Pipelines for the development of the natural gas industry of Trinidad and Tobago.
