MADE BY THE TRINIDAD AND TOBAGO FREE ZONES COMPANY LIMITED  
UNDER SECTION 15 OF THE TRINIDAD AND TOBAGO FREE ZONES ACT

THE TRINIDAD AND TOBAGO FREE ZONES ORDER, 2012

1. This Order may be cited as the Trinidad and Tobago Free Zones Citation  
Order, 2012.

2. In this Order—

Interpretation

“the Company” means the Trinidad and Tobago Free Zones  
Company Limited; and

“the Free Zones” means the designated Free Zones comprising  
that piece or parcel of land situate in the Ward of La Brea in  
the island of Trinidad, being portion of the industrial Estate  
comprising ten point eight six eight five hectares  
(10.8685 Ha) more or less, which is bounded to the north by  
a 100.0 m wide buffer zone owned by the National Energy  
Corporation of Trinidad and Tobago marked in green  
(Points A–C), bounded to the east by a buffer zone owned by  
the National Energy Corporation of Trinidad and Tobago  
marked in green (Points C–D), bounded to the south by a  
30.0 m wide estate corridor marked in orange (Points D–F)  
and bounded to the west by an area zoned for industrial use  
marked in white (Points F–A) owned by the National  
Energy Corporation of Trinidad and Tobago. The survey  
plan was prepared in January, 2012, by Winston  
Mohammed, licensed Land Surveyor.

3. (1) The Company grants approval to BREDERO SHAW MIDDLE Grant of  
EAST LTD. as an approved enterprise to store anti-corrosion coated approval  
steel pipe, iron ore, reinforcing wire and various other materials to be  
used in the concrete coating process in the Free Zones for and in  
connection with the approved activity of manufacture of concrete weight  
coating to steel pipe in the Free Zone designated by Legal Notice No. 13  
of 2012, as from the 3rd day of February, 2012.

(2) The approval granted under subclause (1) shall be subject to the condition that BREDERO SHAW MIDDLE EAST LTD. shall comply with the terms and conditions of the Agreements made between BREDERO SHAW MIDDLE EAST LTD. and the Company with respect to—

- (a) the payment of annual fees to the Company;
- (b) the provision of security; and
- (c) other requirements for operation by BREDERO SHAW MIDDLE EAST LTD. in the Free Zones.
