THE POLICE SERVICE ACT, CHAP. 15:01

REGULATIONS

MADE BY THE PRESIDENT UNDER SECTION 78 OF THE POLICE SERVICE
ACT AND SUBJECT TO AFFIRMATIVE RESOLUTION OF THE HOUSE OF
REPRESENTATIVES

THE POLICE SERVICE (AMENDMENT) REGULATIONS, 2011

1. These Regulations may be cited as the Police Service Citation
(Amendment) Regulations, 2011.

2. In these Regulations, “the Regulations” means the Police Service Interpretation
Regulations, 2007. L.N. No. 145 of
2007

3. The Regulations are amended by inserting after Regulation 62 Regulation 62A
the following regulation: inserted

“Special duty 62A. (1) An officer shall be paid a special duty
allowance allowance at a rate approved by the Minister of
Finance.

(2) The payments of the special duty
allowance to officers from 1st October, 2010 to the
coming into force of these Regulations are
validated.”.

4. The Regulations are amended by inserting after Regulation 183 Regulation 183A
the following regulation: inserted

“Computation 183A. (1) An officer in the First or Second
of pension in Division of the Police Service, who has acted in a
acting higher office for a continuous period of at least
capacity prior three years immediately prior to—
to compulsory
retirement

(a) the date of his compulsory retirement; or

(b) the date on which he proceeds on annual
leave immediately preceding the date of
his compulsory retirement,

shall be eligible to have his pension, gratuity or
other allowance calculated as if he were
substantively appointed in that higher office.

(2) Subject to subregulation (1), an officer
is required to pay all outstanding arrears of

contribution calculated on the basis of the salary which he would have received in the higher office.

(3) All outstanding arrears of contribution referred to in subregulation (2), shall be deducted as a lump sum from the gratuity payable to the officer.

(4) Subregulations (1), (2) and (3) are deemed to have come into effect from 1st January, 2004.

(5) The payments made to officers under this Regulation from 1st January, 2004 to the coming into force of these Regulations are validated.”.

Regulation 185
amended

5. Regulation 185 of the Regulations is amended—

(a) in subregulations (1) and (3), by inserting after the words “completed month of service” respectively, the following words:

“or the sum of—

(a) one thousand, one hundred and fifty dollars per month, with effect from 1st October, 2006;

(b) one thousand, six hundred and fifty dollars per month, with effect from 1st October, 2007;

(c) one thousand, nine hundred and fifty dollars per month, with effect from 1st October, 2008; or

(d) three thousand dollars per month, with effect from 1st September, 2010,

whichever is the greater”; and

(b) in subregulation (7), by inserting after the words “completed month of service” the following words:

“or the sum of—

(a) one thousand, one hundred and fifty dollars per month, with effect from 1st October, 2006;

(b) one thousand, six hundred and fifty dollars per month, with effect from 1st October, 2007;

(c) one thousand, nine hundred and fifty dollars per month, with effect from 1st October, 2008; or

(d) three thousand dollars per month, with effect
from 1st September, 2010,
whichever is the greater.”.
