ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(LABOUR DAY CELEBRATIONS—FYZABAD) ORDER, 2012

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Labour Day Celebrations—Fyzabad) Order, 2012.

2. This Order shall have effect on Tuesday 19th June, 2012, Duration between the hours of 7.00 a.m. and 12.00 midnight.

3. Parking is prohibited on—

Parking
prohibited

- (a) Fyzabad-Guapo Road, between Uriah Butler Avenue and Gowers Well Road;
- (b) Easy Street, between Fyzabad-Guapo Road and Coolman Trace;
- (c) Coolman Trace, between Easy Street and Fyzabad-Guapo Road;
- (d) Fyzabad-Guapo Road, between Coolman Trace and Uriah Butler Avenue;
- (e) Lum Tack Hill;
- (f) Delhi Road, between John Jules Trace and Fyzabad-Oropouche Road;
- (g) Fyzabad-Oropouche Road, between Delhi Road and Monteil Trace;
- (h) Gowers Well Road, between Fyzabad-Guapo Road and John Jules Trace;
- (i) John Jules Trace, between Delhi Road and Gowers Well Road;
- (j) Uriah Butler Avenue, between Dollar Value Supermarket and Fyzabad Police Station;
- (k) Fyzabad-Oropouche Main Road, between Avocat Junction and Charlie King Junction;

-
- (l) Fyzabad-Oropouche Road, between Lum Tack Hill and Jimdar Street;
- (m) Siparia Old Road, between Avocat Junction and Samlal Trace, from 7.00 a.m. to 12.00 midday; and
- (n) Fyzabad-Oropouche Road, between Avocat Junction and 200 metres north of the junction, from 7.00 a.m. to 12.00 midday.
- Vehicular traffic prohibited 4. Vehicular traffic is prohibited on Fyzabad-Guapo Road, between Uriah Butler Avenue and Charlie King Junction.
- Traffic routes 5. (1) Vehicular traffic approaching Fyzabad from Oropouche may either—
- (a) turn left at Avocat Junction onto Siparia Old Road, continue onto Fyzabad-Guapo Road ending at Fyzabad Secondary School; or
- (b) turn right onto Berridge Trace, left onto Mon Desir Road, left onto Delhi Road and continue onto Gowers Well Road.
- (2) Vehicular traffic proceeding to Siparia from—
- (a) Fyzabad, shall proceed in an easterly direction onto Uriah Butler Avenue and then onto Fyzabad-Guapo Road; and
- (b) Forest Reserve, shall proceed in an easterly direction onto Uriah Butler Avenue and then onto Fyzabad-Guapo Road.
- (3) Notwithstanding subclause (2), between 2.00 p.m. and 10.00 p.m., vehicles proceeding to Siparia *via* Fyzabad shall proceed along Delhi Road onto Gowers Well Road, continue onto Fyzabad-Guapo Road and then onto Uriah Butler Avenue or the Oilfield Road through Sudama Village and Spring Trace.
- Emergency routes 6. In an emergency—
- (a) vehicles proceeding to San Fernando *via* Fyzabad shall proceed along Delhi Road, onto Lutchman Drive, continue onto Sewlal Trace *via* Fyzabad Main Road, Pepper Village; and
- (b) vehicles proceeding to Siparia *via* Fyzabad shall proceed along Delhi Road, onto John Jules Trace, continue onto Gowers Well Road, turn right onto Guapo Road, turn left onto Uriah Butler Avenue and continue onto Fyzabad-Guapo Road.

7. Without prejudice to any other liability incurred by the Removal and
commission of a summary offence, vehicles found parked in impounding of
contravention of this Order may be removed by the Police and vehicles
impounded and dealt with in accordance with section 108(1)(b) of the unlawfully
Motor Vehicles and Road Traffic Act. parked
