UNDER SECTION 15 OF THE TRINIDAD AND TOBAGO FREE ZONES
ACT

THE TRINIDAD AND TOBAGO FREE ZONES (AMENDMENT)
ORDER, 2012

1. This Order may be cited as the Trinidad and Tobago Free Zones Citation
(Amendment) Order, 2012.

2. In this Order—

Interpretation

“the Order” means the Trinidad and Tobago Free Zones (No. 2)
Order, 2007.

“the Company” means the Trinidad and Tobago Free Zones
Company Limited; and

“the Free Zones” means the designated Free Zones comprising
three thousand, four hundred and sixty-one point nine
square meters (3,461.9 m²), situate in the Ward of Pointe-a-
Pierre (being portion of a larger parcel of land comprising
five hundred and sixty-six acres and eighteen perches)
described in Deed registered as No. 75 of 1929, which said
parcel of land is more particularly described and coloured
pink on the Plan of Survey dated the 3rd day of July, 2006,
prepared by Jamal Sookoor, Licensed Land Surveyor, and
the designated Free Zone, the first hereto comprising
two thousand, three hundred and seventy-four point zero
square metres (2,374.0 m²) and the second thereof
comprising two thousand, three hundred and sixty-eight
point six square metres (2,368.6 m²) situate in the Ward of
Pointe-a-Pierre (being portion of a larger parcel of land
described in Deed No. 119 of 1962) and more particularly
described and coloured pink and marked 115 and 118
respectively, on the Plan of Survey dated the 25th day of
August, 2006, prepared by Shri Persad Maharaj, Licensed
Land Surveyor.

3. (1) The Company grants approval to EthylChem Ltd. as an ^{Grant of}
Approved Enterprise to undertake the approved activity of ^{Approval and}
manufacture of fuel of grade biodiesel at the Free Zone, as from the ^{cessation of}
31st day of May, 2012 and to cease the previously approved activity of ^{former}
^{activity}

manufacture of fuel grade dehydrated ethanol as from the 31st day of May, 2012 in the Free Zone designated by Legal Notices Nos. 180 of 2007 and 303 of 2010 as from the 31st day of May, 2012.

(2) The approval granted under subclause (1) shall be subject to the condition that EthylChem Ltd. shall comply with the terms and conditions of the Agreements made between EthylChem Ltd. and the Company with respect to—

- (a) the payment of annual fees to the Company;
- (b) the provision of security; and
- (c) other requirements for operation by EthylChem Ltd. in the Free Zones.

Commencement 4. This Order is deemed to have come into effect on the 31st day of May, 2012.
