REGULATIONS

MADE BY THE MINISTER UNDER SECTION 76 OF THE EXCISE (GENERAL PROVISIONS) ACT

THE EXCISE (FEES) (AMENDMENT) REGULATIONS, 2014

1. These Regulations may be cited as the Excise (Fees) Citation
(Amendment) Regulations, 2014.

2. In these Regulations, “the Regulations” means the Excise (Fees) Interpretation
Regulations. Chap. 78:50

3. Regulation 6 of the Regulations is amended in the Table— Regulation 6
amended

(a) in paragraph (a)—

- (i) in subparagraph (i), by deleting the words “\$67.84” and substituting the words “\$75.44”; and
- (ii) in subparagraph (ii), by deleting the words “\$67.84” and “\$90.44” and substituting the words “\$75.44” and “\$100.58”, respectively; and

(b) in paragraph (b)—

- (i) in subparagraph (i), by deleting the words “\$57.55” and substituting the words “\$64.20”; and
- (ii) in subparagraph (ii), by deleting the words “\$57.55” and “\$76.74” and substituting the words “\$64.20” and “\$85.60”, respectively.

4. Regulation 7 of the Regulations is revoked and the following Regulation 7
regulation is substituted: revoked and

“Overtime
Fees

7. (1) The overtime fees in respect of the services of officers out of normal office hours are payable to the Comptroller at the rates and for the years set out in the Schedule.

Schedule

(2) The fees set out in the Schedule in respect of—

- (a) the year 2008, are deemed to have come into effect on 1st January, 2008;

- (b) the year 2009, are deemed to have come into effect on 1st January, 2009;
- (c) the year 2010, are deemed to have come into effect on 1st January, 2010; and
- (d) the year 2011, are deemed to have come into effect on 1st January, 2011.

(3) Notwithstanding subregulation (1), any person who utilized any of the services mentioned in the Schedule shall be exempt from the payment of any sums of monies representing the difference between the rates which were payable, in respect of those services, before 1st January, 2008 and the rates set out in the Schedule.”.
