MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(CARNIVAL) ORDER, 2006

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Carnival) Order, 2006.

PART I

PORT-OF-SPAIN

Division 1—Vehicular Traffic and Parking

2. (1) On Monday 27th February, 2006, vehicular traffic and parking are prohibited on the following roads and on all roads lying within and bounded by them, from 2.00 a.m. to 9.00 p.m.:

- (a) Duke Street, between Belgrade Street and Wrightson Road;
- (b) Park Street, between Flament Street and Piccadilly Street;
- (c) Flament Street, between Park Street and Wrightson Road;
- (d) Independence Square North, between Wrightson Road and Piccadilly Street;
- (e) Independence Square South, between Wrightson Road and Piccadilly Street;
- (f) St. Joseph Road, between Piccadilly Street and Viera Street;
- (g) Charlotte Street, between Oxford Street and South Quay;
- (h) Nelson Street;
- (i) Duncan Street;
- (j) Fraser Street;
- (k) Richmond Street;
- (l) St. Vincent Street, between Oxford Street and Wrightson Road;
- (m) Abercromby Street, between South Quay and Oxford Street;

- (o) Henry Street, between South Quay and New Street;
- (p) Sackville Street;
- (q) Broadway;
- (r) Queen Street;
- (s) South Quay, between Viera Street and St. Vincent Street;
- (t) New Street, between Henry Street and Charlotte Street;
- (u) Belmont Circular Road, between Charlotte Street and the entrance to the Port-of-Spain General Hospital;
- (v) Piccadilly Street;
- (w) Phillip Street; and
- (x) Tragarete Road.

(2) On Monday 27th February, 2006, from 2.00 a.m. to 9.00 p.m. and on Tuesday 28th February, 2006, from 6.00 a.m. to 9.00 p.m., vehicular traffic is prohibited on the following roads specified in subclause (4) and on all roads lying within and bounded by specified roads.

(3) On Monday 27th February, 2006, from 2.00 a.m. to 9.00 p.m. and Tuesday 28th February, 2006 from 6.00 a.m. to 9.00 p.m. parking is prohibited on the roads specified in subclause (4) and on all roads lying within and bounded by specified roads.

(*b*) Stone Street.

(2) On Monday 27th February, 2006, from 2.00 a.m. to 9.00 p.m. and on Tuesday 28th February, 2006, from 6.00 a.m. to 9.00 p.m., parking is prohibited on the following:

(*a*) Circular Road;

(*c*) St. Clair Avenue;

(*d*) Damian Street;

- (u) Oxford Street, east of Observatory Street;
- (v) Belmont Circular Road, between Observatory Street and Queen's Park East;
- (w) Belmont Circular Road, between Observatory Street and the entrance to the Port-of-Spain General Hospital;
- (x) Jerningham Avenue, between Archer Street and Norfolk Street;
- (y) Archer Street;
- (z) Cadiz Road;
- (aa) Lady Young Road, between the entrance to the Trinidad Hilton and St. Ann's Roundabout; and
- (bb) Serpentine Road.

(3) On Monday 27th February, 2006 and Tuesday 28th February, 2006, from 2.00 a.m. to midnight, parking is prohibited on the following:

- (a) the portion of South Quay and the Eastern Main Road, between Viera Street, Port-of-Spain and Bushe Street, San Juan; and
- (b) Abattoir Road, with the exception of the taxis specified in clauses 13 and 14.

4. (1) On Monday 27th February, 2006, from 2.00 a.m. to 9.00 p.m., ^{One-way} vehicular traffic shall proceed along Stone Street, between Wrightson ^{traffic} Road and Park Street, in a southerly direction only.

(2) On Monday 27th February, 2006, from 2.00 a.m. to 9.00 p.m. and on Tuesday 28th February, 2006, from 6.00 a.m. to 9.00 p.m., vehicular traffic shall proceed on—

- (a) Archer Street, between Belmont Circular Road and Jerningham Avenue, in a southerly direction only;
- (b) Cadiz Road, in an easterly direction only; and
- (c) Viera Street, from St. Joseph Road to Abattoir Road, in a southerly direction only.

5. Notwithstanding any enactment to the contrary, from 3.00 a.m. ^{Two-way} on Monday 27th February, 2006 to 6.00 a.m. on Wednesday ^{traffic} 1st March, 2006, vehicular traffic may proceed in both directions—

- (a) around the Queen's Park Savannah, between Belmont Circular Road and Serpentine Road;
- (b) on Observatory Street, between Quarry Street and Belmont Circular Road; and
- (c) on Belmont Circular Road, between Observatory Street and the entrance to the Port-of-Spain General Hospital.

- Route for vehicles on an emergency to Port-of-Spain General Hospital
6. Vehicles proceeding to the Port-of-Spain General Hospital on an emergency shall proceed along one of the following routes and shall leave by the reverse route:
- (a) north along Henry Street, east onto New Street and onto Belmont Circular Road to the hospital;
 - (b) south from the Queen's Park Savannah, south on Dundonald Street, east along Gordon Street and south on Charlotte Street to the hospital;
 - (c) east from Belmont Circular Road and Observatory Street to the hospital; and
 - (d) from Adam Smith Square and Victoria Square, north on French Street, north on Maraval Road to Circular Road and Queen's Park East to the hospital.

Division 2—Taxi and Maxi-taxi Stands

7. This Division shall have effect from 2.00 a.m. on Monday 27th February, 2006, to midnight on Tuesday 28th February, 2006.

 - (b) the Chaguanas taxi stand, from the northern carriageway of the Beetham Highway, east of Broadway, facing east.

12. Taxis assigned to Morvant/Trou Macaque shall operate on the northern side of the Eastern Main Road, east of the flyover.

13. Taxis assigned to taxi stands on Henry Street, between Independence Square South and South Quay (Tunapuna/Arima/Sangre Grande) shall operate from the southern side of Abattoir Road, east of Viera Street.

19. Route 1 maxi-taxis (yellow band) shall enter the maxi-taxi stand on South Quay by way of the Beetham Highway and exit by way of South Quay, on the southern side, forty metres east of the Beetham Highway.

Division 3—Parade of Bands

20. (1) Subject to subclause (2), bands shall enter the Queen's Park Savannah Competition Centre through the entrance on Queen's Park West and leave through any exit on Queen's Park West, that is to say, Victoria Avenue, Stanmore Avenue or Cipriani Boulevard.

(2) Bands from Belmont shall enter the Queen's Park Savannah from Queen's Park East.

21. Bands shall enter the Adam Smith Square Competition Centre by way of Tragarete Road, turn south onto Pole Carew Street and Ana Street, then proceed east along Ariapita Avenue.

Entry of vehicles onto the Queen's Park Savannah 25. Vehicles shall enter the Queen's Park Savannah at the following points:
 (a) Queen's Park East, near St. Ann's Roundabout;
 (b) Queen's Park West, opposite Dundonald Street;
 (c) Circular Road, opposite President's House; and
 (d) Maraval Road, opposite Whitehall.

Parking of vehicles on Queen's Park Savannah 26. (1) Notwithstanding any enactment to the contrary, motorists attending the parade of bands at the Grand Stand may park their vehicles on the Queen's Park Savannah during the period commencing three hours before the start of the function and ending three hours after the closure of the function.

(2) Parking on the Queen's Park Savannah shall be in accordance with the directions of the police officer on duty.

Division 4—Traffic Lights

Automatic traffic lights 27. Automatic traffic lights shall not be in operation from 2.00 a.m. on Monday 27th February, 2006, to midnight on Tuesday 28th February, 2006.
