ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(NATIONAL DAY OF REMEMBRANCE) ORDER, 2006

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (National Day of Remembrance) Order, 2006.

2. This Order has effect from 9.00 a.m. to 1.00 p.m. on Sunday 12th November, 2006. Duration

3. Parking is prohibited on—

- (a) Queen's Park West, between Queen's Park East and Frederick Street; Parking prohibited
- (b) Queen's Park East;
- (c) Keate Street, between Charlotte Street and Chancery Lane;
- (d) Gordon Street, between Charlotte Street and Richmond Street;
- (e) Frederick Street, between Gordon Street and Queen's Park West;
- (f) Abercromby Street, between Gordon Street and Keate Street;
- (g) Pembroke Street, between Keate Street and Gordon Street;
- (h) New Street, between Pembroke Street and Charlotte Street;
- (i) Chancery Lane; and
- (j) Jerningham Avenue, between Queen's Park East and Norfolk Street.

4. (1) Notwithstanding Clause 3, parking is permitted on—

- (a) Frederick Street, between the western entrance to Memorial Park and Keate Street, for— Parking permitted
 - (i) His Excellency, the President of the Republic of Trinidad and Tobago;

- (ii) the Honourable Prime Minister of the Republic of Trinidad and Tobago;
- (iii) the Honourable Chief Justice of the Republic of Trinidad and Tobago;
- (iv) the President of the Senate;
- (v) the Speaker of the House of Representatives; and
- (vi) heads of religious denominations who are participating in the ceremony at the Cenotaph;
- (b) Keate Street, between Frederick Street and Abercromby Street for Government Ministers;
- (c) Keate Street, between Abercromby Street and Chancery Lane for members of the Diplomatic and Consular Corps;
- (d) Abercromby Street, between Gordon Street and Keate Street for members of the Diplomatic and Consular Corps;
- (e) Pembroke Street, for members of the Diplomatic and Consular Corps;
- (f) Duprey Drive, for—
 - (i) the Mayor of Port-of-Spain;
 - (ii) the Mayor of San Fernando;
 - (iii) the Mayor of Arima;
 - (iv) the Mayor of Point Fortin;
 - (v) the Mayor of Chaguanas;
 - (vi) the Commissioner of Police;
 - (vii) the Chief of the Defence Staff;
 - (viii) the Commanding Officer of the Trinidad and Tobago Regiment;
 - (ix) the Commanding Officer of the Trinidad and Tobago Coast Guard;
 - (x) the Chief Fire Officer;
 - (xi) the Officer commanding the National Day of Remembrance Parade; and
 - (xii) the Permanent Secretary, Ministry of National Security; and
- (g) Queen's Park Savannah opposite the Princess Building Grounds, for other persons, in accordance with the directions of the police officers on duty.

(2) Vehicles used by persons referred to in subclauses (1)(c), (d) and (e) shall bear the appropriate windscreen stickers.

Roads closed

5. The following roads shall be closed to vehicular traffic from 9.00 a.m. to 12.00 noon:

- (a) Frederick Street, between Queen's Park West and Keate Street;

- (b) Queen's Park West, between Queen's Park East and Frederick Street;
 - (c) Queen's Park East, between Jerningham Avenue and Queen's Park West;
 - (d) Charlotte Street, between Queen's Park West and Gordon Street;
 - (e) Keate Street, between Charlotte Street and Abercromby Street; and
 - (f) Pembroke Street, between Gordon Street and Keate Street.
6. From 9.00 a.m. to 12.00 noon motorists proceeding— ^{Traffic diverted}
- (a) south on Queen's Park East, shall turn east onto Jerningham Avenue;
 - (b) west on Jerningham Avenue, between Belmont Circular Road and Norfolk Street, shall turn north or south onto Norfolk Street;
 - (c) south on Archer Street, shall turn east onto Jerningham Avenue;
 - (d) north on Charlotte Street, shall turn west onto Gordon Street; and
 - (e) north on Henry Street, shall turn east onto New Street or west onto Gordon Street.
7. From 9.00 a.m. to 12.00 noon, motorists on Jerningham Avenue, ^{One-way traffic} between Queen's Park East and Norfolk Street, shall proceed in an easterly direction only.
8. During the observance of the two minutes of silence from ^{Two minutes silence} 11.00 a.m. to 11.02 a.m. police officers on duty shall bring to a standstill all vehicular traffic within the area bounded on the north by Queen's Park West, on the south by Gordon Street, on the east partly by Queen's Park East and partly by Charlotte Street and on the west by Chancery Lane.
9. Without prejudice to any other liability incurred by the ^{Removal and impounding of vehicles unlawfully parked} commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
