MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF
THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(SINGLE PAN BANDS SEMI-FINALS) ORDER, 2005

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Single Pan Bands Semi-Finals) Order, 2005. Citation

2. This Order shall have effect between the hours of 5.00 p.m. on 29th January, 2005 and 2.00 a.m. on 30th January, 2005. Duration

3. Parking and vehicular traffic are prohibited on the following roads: Road closed parking prohibited

- (a) St. Vincent Street, between Duke Street and Independence Square North;
- (b) Independence Square North, between Wrightson Road and Henry Street;
- (c) Frederick Street, between Duke Street and Independence Square North;
- (d) Queen Street, between Henry Street and St. Vincent Street;
- (e) Knox Street, between St. Vincent Street and Frederick Street;
- (f) Hart Street, between Frederick Street and St. Vincent Street;
- (g) Abercromby Street, between Independence Square South and Duke Street;
- (h) Pembroke Street, between Knox Street and Duke Street;
- (i) Prince Street, between Henry Street and Frederick Street; and
- (j) Chacon Street, between Queen Street and Independence Square South.

4. Parking is prohibited on the following roads: Parking prohibited

- (a) Independence Square South, between Broadway and St. Vincent Street; and
- (b) Cipriani Circle.

- Parking permitted 5. Notwithstanding clause 3(a), vehicles conveying steelpans may park on St. Vincent Street, between Duke Street and Independence Square North.
- Taxi stands 6. Taxis shall operate as follows:
 St. Ann's Taxi Stand
 (a) taxis plying for hire on Hart Street, shall ply for hire on St. Vincent Street between South Quay and Independence Square South on the eastern side;
 St. James Taxi Stand
 (b) taxis plying for hire on Hart Street shall ply for hire on St. Vincent Street, between South Quay and Independence Square South on the western side; and
 Ice House and Marine Square Taxi Stand
 (c) taxis that ply for hire on the southern side of Independence Square North, between Abercromby Street and St. Vincent Street and the eastern and western sides of Cipriani Circle, shall ply for hire on the northern and southern sides of Independence Square South, between St. Vincent Street and Edward Street.
- Band route 7. (1) Bands shall assemble on St. Vincent Street and Independence Square North, then proceed east along Independence Square North, north along Frederick Street and west onto Knox Street in front of City Hall.
 (2) On completion of their performance, bands will continue west along Knox Street, onto Abercromby Street and end at Independence Square North.
- Removal and impounding of vehicles unlawfully parked
 Chap. 48:50 8. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order, may be removed by the police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
