MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(LABOUR DAY CELEBRATIONS—FYZABAD) ORDER, 2005

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Labour Day Celebrations—Fyzabad) Order, 2005. Citation

2. This Order shall have effect between the hours of 10.00 a.m. and 12:00 midnight on Sunday, 19th June, 2005. Duration

3. No person shall park any vehicle on the following roads: Parking prohibited
- (a) Fyzabad-Guapo Road, between Uriah Butler Avenue and Gowers Well Road;
 - (b) Easy Street, between Fyzabad-Guapo Road and Coolman Trace;
 - (c) Coolman Trace, between Easy Street and Fyzabad-Guapo Road;
 - (d) Fyzabad-Guapo Road, between Coolman Trace and Uriah Butler Avenue;
 - (e) Lum Tack Hill;
 - (f) Delhi Road, between John Jules Trace and Fyzabad-Oropouche Road;
 - (g) Fyzabad-Oropouche Road, between Delhi Road and Monteil Trace;
 - (h) Gowers Well Road, between Fyzabad-Guapo Road and John Jules Trace; and
 - (i) John Jules Trace, between Delhi Road and Gowers Well Road.

4. Vehicular traffic is prohibited on Fyzabad-Guapo Road, between Uriah Butler Avenue and Charlie King Junction. Vehicular traffic prohibited

5. Notwithstanding paragraph 4, Public Transport Service Corporation buses may ply their normal routes. Bus routes

6. (1) Vehicular traffic entering Oropouche from—
- (a) Fyzabad, shall proceed east onto Uriah Butler Avenue, onto Fyzabad-Guapo Road, onto Lum Tack Hill and onto Fyzabad-Oropouche Road; and
 - (b) Siparia, shall proceed west along Fyzabad-Guapo Road, onto Lum Tack Hill and onto Fyzabad-Oropouche Road.
- (2) Vehicular traffic entering Siparia from—
- (a) Fyzabad, shall proceed in an easterly direction, onto Uriah Butler Avenue and continue east onto Fyzabad-Guapo Road;
 - (b) Forest Reserve, shall proceed in an easterly direction, onto Uriah Butler Avenue and then onto Fyzabad-Guapo Road;
 - (c) Delhi Road, shall proceed along Lum Tack Hill and east onto Fyzabad-Guapo Road; and
 - (d) Oropouche, shall proceed along Lum Tack Hill and east onto Fyzabad-Guapo Road.
- (3) Vehicular traffic entering Forest Reserve from Oropouche, shall proceed along Lum Tack Hill, east onto Fyzabad-Guapo Road, west onto Uriah Butler Avenue and onto the Fyzabad-Guapo Road.
- (4) Vehicular traffic entering Delhi Road from Fyzabad-Guapo Road, shall proceed north onto Lum Tack Hill, onto Fyzabad-Oropouche Road and west onto Dehli Road.

7. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
