ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(SIPARIA KI MAI CELEBRATIONS) ORDER, 2003

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Siparia Ki Mai Celebrations) Order, 2003.

2. This Order has effect from 3.00 p.m. on Thursday, 17th April, Duration 2003 to 12.00 noon on Friday, 18th April, 2003.

3. Vehicular traffic is prohibited on the following roads:

Vehicular

- (a) George Street, between Edward Street and La Pastora Street;
- (b) Mary Street, between Edward Street and La Pastora Street; and
- (c) La Pastora Street, between Victoria Street and Siparia-Erin Road.

4. Parking is prohibited on the following roads:

Parking
prohibited

- (a) De Gannes Lane;
- (b) Victoria Street, between Coora Road and La Pastora Street;
- (c) Siparia Road, between Potter Lane and Siparia-Erin Road;
- (d) Edward Street, between Mary Street and Siparia-Erin Road;
- (e) Coora Road, between Mary Street and Siparia-Erin Road; and
- (f) Mary Street, between Station Street and Coora Road.

5. (1) Motorists shall proceed in a westerly direction, along the Siparia-Erin Road, between Edward Street and La Pastora Street. Traffic routes

(2) Motorists approaching Siparia from Erin, along the Siparia-Erin Road proceeding towards San Fernando, shall turn north onto Siparia Old Road, east onto Gambal Street, onto Grell Street and east onto the Siparia-Erin Road.

(3) Motorists approaching Siparia from Fyzabad, along the Siparia Old Road, shall proceed east onto De Gannes Lane, south onto Coora Road and east or west onto the Siparia-Erin Road.

6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
