ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF  
THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)  
(CALYPSO FIESTA, SOUTH STEELBAND PANORAMA AND  
SOUTH KIDDIES CARNIVAL) ORDER, 2000

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Calypso Fiesta, South Steelband Panorama and South Kiddies Carnival) Order, 2000.

2. This Order takes effect on the dates and between the times specified hereunder:

- (a) 5.00 p.m. on 19th February, 2000 to 3.00 a.m. on 20th February, 2000 (South/Central Panorama Preliminaries);
- (b) 5.00 p.m. on 23rd February, 2000 to 3.00 a.m. on 24th February, 2000 (South/Central Panorama Zonal Final);
- (c) 6.00 a.m. on 26th February, 2000 to 12 midnight on 27th February, 2000 (Calypso Fiesta);
- (d) 6.00 a.m. on 5th March, 2000 to 12 midnight on 6th March, 2000 (Kiddies Carnival).

3. Vehicles may be parked on the following streets:

- (a) Princess Margaret Street on the western side;
- (b) Rambaransingh Street on the northern side;
- (c) Turton Street on the western side; or
- (d) Prince Charles Street on the southern side.

4. Vehicles conveying steelbands to Skinner Park shall proceed west along Park Street.

5A. For the purposes of South Steelband Panorama and Calypso Fiesta the following streets shall be closed to vehicular traffic:

- (a) Ciperio Street, between Westwood Street and Rienzi-Kirton Highway;

- (b) Todd Street, between Rushworth Street and Rienzi-Kirton Highway;
- (c) Park Street, between Ciperio Street and Todd Street;
- (d) Scott Street, between Ciperio Street and Richards Street;
- (e) the east bound lane of the Rienzi-Kirton Highway from Todd Street to Ciperio Street.

5B. For the purposes of South Kiddies Carnival the following streets shall be closed to vehicular traffic:

- (a) Circular Road;
- (b) Royal Road;
- (c) Coffee Street, between Navet Road and Kelshall Street;
- (d) Ciperio Street, between Coffee Street and the northern end of the Rienzi-Kirton Highway.

One-way traffic

6. Motorists using Shah Street shall proceed in a northerly direction only.

Two-way traffic

7. Vehicles proceeding along Rienz-Kirton Highway shall proceed in both directions along the west bound lane.

No parking

8. There shall be no parking on Balisier Avenue.

Removal and impounding of vehicles unlawfully parked

9. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
