ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF
THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(SINGLE PAN BANDS PRELIMINARY) ORDER, 2000

1. This Order may be cited as the Traffic Restriction (Temporary ^{Citation} Provisions) (Single Pan Bands Preliminary) Order, 2000.
2. This Order has effect between the hours of 5.00 p.m. on Friday ^{Duration} 18th February, 2000 and 5.00 a.m. on Saturday 19th February, 2000.
3. Parking and vehicular traffic are prohibited on the following ^{Road closed parking prohibited} roads:
 - (a) Independence Square North, between Wrightson Road and Charlotte Street;
 - (b) Richmond Street, between London Street and Independence Square North;
 - (c) Edward Street, between Independence Square North and Independence Square South;
 - (d) St. Vincent Street, between Duke Street and Independence Square South;
 - (e) Abercromby Street, between Independence Square North and Independence Square South;
 - (f) Chacon Street, between Queen Street and Independence Square South;
 - (g) Frederick Street, between Duke Street and Independence Square North;
 - (h) Cipriani Circle;
 - (i) Queen Street, between Henry Street and Richmond Street;
 - (j) Knox Street, between Frederick Street and Abercromby Street;
 - (k) Hart Street, between Frederick Street and Abercromby Street.
4. Notwithstanding paragraph 3(a), vehicles conveying ^{Parking restricted} steel pans may park on Independence Square North, between Wrightson Road and Edward Street on both sides of the road.

- Taxi stands 5. Taxis shall operate as follows:
- St. James (a) taxis plying for hire on Hart Street, between Frederick Street and Abercromby Street (St. James) will now ply for hire on St. Vincent Street, between Independence Square South and South Quay on the western side facing north;
- St. Ann's (b) taxis plying for hire on Hart Street, between Frederick Street and Abercromby Street (St. Ann's) will now ply for hire on Edward Street, between Independence Square South and South Quay on the western side facing north;

Stand (c) taxis plying for hire on the southern side of Independence Square North, between Abercromby Street and St. Vincent Street and the eastern and western side of Cipriani Circle, between Independence Square North and Independence Square South will now ply for hire on South Quay, between Chacon Street and Broadway facing east.
- Band route 6. Bands shall assemble on Independence Square North between Edward Street and St. Vincent Street, and proceed east along Independence Square North, north along Frederick Street, west along Knox Street and disperse.

Chap. 48:50 7. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
