MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(LABOUR DAY CELEBRATIONS—FYZABAD) ORDER, 2000

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Labour Day Celebrations—Fyzabad) Order, 2000. Citation

2. This Order shall have effect between the hours of 10.00 a.m. and 12.00 midnight on Monday 19th June, 2000. Duration

3. No person shall park any vehicle on the following roads: Parking prohibited
- (a) Fyzabad-Guapo Road, between Sanderson Avenue and Gowers Well Road;
 - (b) Easy Street, between Fyzabad-Guapo Road and Coolman Trace;
 - (c) Coolman Trace, between Easy Street and Siparia-Fyzabad Road;
 - (d) Siparia-Fyzabad Road, between Coolman Trace and Sanderson Avenue;
 - (e) Lum Tack Hill;
 - (f) Delhi Road, between John Jules Trace and Fyzabad-Oropouche Road;
 - (g) Fyzabad-Oropouche Road, between Delhi Road and Monteil Trace;
 - (h) Gowers Well Road, between Fyzabad-Guapo Road and John Jules Trace; and
 - (i) John Jules Trace, between Delhi Road and Gowers Well Road.

4. Vehicular traffic is prohibited on Fyzabad-Guapo Road, between Sanderson Avenue and Charlie King Junction. Road closed traffic prohibited

5. Notwithstanding paragraph 4, Public Transport Service Corporation buses may ply their normal routes. Bus routes

- Traffic routes
6. (1) Vehicular traffic entering Oropouche from—
- (a) Fyzabad, shall proceed east into Sanderson Avenue, into Siparia-Fyzabad Road, into Lum Tack Hill and into Fyzabad-Oropouche Road;
 - (b) Siparia, shall proceed along Siparia-Fyzabad Road, west into Lum Tack Hill and into Fyzabad-Oropouche Road.
- (2) Vehicular traffic entering Siparia from—
- (a) Fyzabad, shall proceed in an easterly direction, into Sanderson Avenue, continuing east into Siparia-Fyzabad Road;
 - (b) Forest Reserve, shall proceed in a south-westerly direction into Sanderson Avenue and then south into Siparia-Fyzabad Road;
 - (c) Delhi Road along Lum Tack Hill, shall proceed east into Siparia-Fyzabad Road; and
 - (d) Oropouche along Lum Tack Hill, shall proceed north into Siparia-Fyzabad Road.
- (3) Vehicular traffic entering Forest Reserve from Oropouche, shall proceed along Lum Tack Hill, north into Siparia-Fyzabad Road, east into Sanderson Avenue and into Fyzabad-Guapo Road.
- (4) Vehicular traffic entering Delhi Road from Siparia along Siparia-Fyzabad Road, shall proceed east into Lum Tack Hill into Fyzabad-Oropouche Road and west into Delhi Road.

7. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
