MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF
THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(SINGLE PAN BANDS SEMI-FINALS) (SOUTH QUAY,
PORT-OF-SPAIN) ORDER, 2002

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Single Pan Bands Semi-Finals) (South Quay, Port-of-Spain) Order, 2002. Citation

2. This Order has effect between the hours of 5:00 p.m. on Saturday 2nd February, 2002 and 2:00 a.m. on Sunday, 3rd February, 2002. Duration

3. Parking and vehicular traffic are prohibited on the following roads: Road closed and parking prohibited

- (a) Broadway, between Independence Square South and Beetham Highway;
- (b) South Quay, between Charlotte Street and Wrightson Road;
- (c) Chacon Street, between Independence Square South and South Quay;
- (d) St. Vincent Street, between Independence Square South and South Quay; and
- (e) Abercromby Street, between Independence Square South and South Quay.

4. Parking is prohibited on the following roads: Parking prohibited

- (a) Independence Square North, between George Street and Wrightson Road;
- (b) George Street, between Independence Square North and Independence Square South;
- (c) Independence Square South, between Nelson Street and Wrightson Road, except for taxis assigned to taxi stands under clause 6(a); and
- (d) South Quay, between George Street and Wrightson Road.

- Parking restriction 5. Notwithstanding clause 3(d), vehicles conveying steelpans may park on St. Vincent Street, between Independence Square South and South Quay.
- Taxi stands 6. Taxis shall operate as follows:
- (a) (i) Diego Martin/Petit Valley taxis plying for hire on South Quay, between Broadway and Abercromby Street, shall ply for hire on Independence Square South, between St. Vincent Street and Wrightson Road on the southern side; and
- (ii) Long Circular/Wrightson Road taxis plying for hire on Chacon Street, between Independence Square South and South Quay, shall ply for hire on Independence Square South, between St. Vincent Street and Wrightson Road on the northern side;
- (b) taxis plying for hire on Broadway, between South Quay and Independence Square South, shall ply for hire on the northern side of the east-bound lane of the Beetham Highway in the following manner:
- (1) CHAGUANAS—east of Broadway; and
- (2) SAN FERNANDO—west of Broadway.
- Band route 7. Bands shall assemble on St. Vincent Street, between South Quay and Independence Square South, then proceed east along South Quay into Broadway and disperse.
- Removal and impounding of vehicles unlawfully parked
Chap. 48:50 8. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order, may be removed by the police and impounded and dealt with in accordance with section 108(1)(b), of the Motor Vehicles and Road Traffic Act.
