THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)  
(FORMAL OPENING OF THE 2001–2002 LAW TERM OF  
THE SUPREME COURT OF THE REPUBLIC OF TRINIDAD  
AND TOBAGO) ORDER, 2001

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Formal Opening of the 2001–2002 Law Term of the Supreme Court of the Republic of Trinidad and Tobago) Order, 2001. Citation

2. This Order has effect between the hours of 6.00 a.m. and 2.00 p.m. on Monday 17th September, 2001. Duration

3. Parking is prohibited on the following roads:

- (a) St. Vincent Street, between Duke Street and Queen Street;
  - (b) Sackville Street, between Richmond Street and St. Vincent Street;
  - (c) Abercromby Street, between Queen Street and Duke Street;
  - (d) Knox Street, between St. Vincent Street and Frederick Street;
  - (e) Edward Street, between Queen Street and Duke Street;
  - (f) Hart Street;
  - (g) the grounds of the southern and western sides of the Red House;
  - (h) Pembroke Street, between Knox Street and Park Street; and
  - (i) Duke Street, between Frederick Street and St. Vincent Street.
- Parking prohibited

4. From 10.00 a.m. to 2.00 p.m. the following roads shall be closed to vehicular traffic: Roads closed to vehicular traffic

- (a) St. Vincent Street, between Duke Street and Queen Street;
- (b) Hart Street;
- (c) Abercromby Street, between Park Street and Queen Street; and
- (d) Knox Street.

| Parking   | <p>7. Parking of vehicles is prohibited on the eastern side of Edward Street, between Queen Street and Sackville Street except for Police and Defence Force vehicles.</p>   |

Without prejudice to any liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order, may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.</p>  |
