(INTERNATIONAL EXPOSITION '96) ORDER, 1996

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (International Exposition '96) Order, 1996. Citation

2. This Order has effect on:

- (a) Friday, 19th April, 1996 from 4.00 p.m. to 1.00 a.m. on Saturday, 20th April, 1996;
- (b) Saturday, 20th April, 1996 from 10.00 a.m. to 1.00 a.m. on Sunday, 21st April, 1996;
- (c) Sunday, 21st April, 1996 from 10.00 a.m. to 1.00 a.m. on Monday, 22nd April, 1996;
- (d) Monday, 22nd April, 1996 from 9.00 a.m. to 12.00 midnight;
- (e) Tuesday, 23rd April, 1996 from 9.00 a.m. to 12.00 midnight;
- (f) Wednesday, 24th April, 1996 from 9.00 a.m. to 12.00 midnight;
- (g) Thursday, 25th April, 1996 from 9.00 a.m. to 12.00 midnight;
- (h) Friday, 26th April, 1996 from 9.00 a.m. to 12.00 midnight;
- (i) Saturday, 27th April, 1996 from 10.00 a.m. to 1.00 a.m. on Sunday, 28th April, 1996;
- (j) Sunday, 28th April, 1996 from 10.00 a.m. to 1.00 a.m. on Monday, 29th April, 1996.

3. Parking is prohibited on the following roads:

- (a) Audrey Jeffers Highway from Wrightson Road to Mucurapo Link Road;
- (b) Fitzblackman Drive;
- (c) Wrightson Road Extension;

- (d) Maraval Parkway;
- (e) Mucurapo Link Road;
- (f) Hamilton Holder Street;
- (g) Hamilton Holder Street Extension;
- (h) Dennis Mahabir Street;
- (i) De Verteuil Street;
- (j) Petra Street;
- (k) Ana Street;
- (l) Belle Smythe Street;
- (m) Ariapita Avenue, between Maraval Parkway and Gallus Street; and
- (n) Wrightson Road, Between Gallus Street and Hamilton Holder Street Extension.

Parking restricted

4. Parking is restricted to the eastern side of the following roads:
- (a) O'Connor Street;
 - (b) Taylor Street.

Public parking

5. Parking is permitted at the following venues:
- (a) Spectrum Compound;
 - (b) Port Authority Compound—Ana Street entrance.

One-way traffic

6. Vehicular traffic shall proceed as follows:
- (a) on Wrightson Road Extension, between Fitzblackman Drive and Ana Street in an easterly direction only;
 - (b) on Fitzblackman Drive, between Maraval Parkway and Wrightson Road Extension—
 - (i) before and during the show in a southerly direction only;
 - (ii) after the show in a northerly direction only.

No right turn

7. Vehicular traffic proceeding south along Dennis Mahabir Street shall not turn right into Wrightson Road Extension.

Removal and impounding of vehicles unlawfully parked

8. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
