MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE  
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)  
(HOSEIN) ORDER, 1996

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Hosein) Order, 1996.

2. This Order shall have effect from—

Commence-  
ment and  
cessation

- (a) 10.00 p.m. on Saturday, 25th May, 1996 to 4.00 a.m. on Sunday, 26th May, 1996;
- (b) 10.00 p.m. on Sunday, 26th May, 1996 to 4.00 a.m. on Monday, 27th May, 1996;
- (c) 10.00 p.m. on Monday, 27th May, 1996 to 4.00 a.m. on Tuesday, 28th May, 1996; and
- (d) 10.00 a.m. to 8.00 p.m. on Tuesday, 28th May, 1996.

3. On the dates and during the times specified in paragraph 2, <sup>One-way</sup> drivers on the roads mentioned below shall proceed as follows: <sup>traffic</sup>

- (a) Lazare Street, between Western Main Road and Carlton Avenue, in a southerly direction only;
- (b) Jerry Street, between Church Street and Western Main Road, in a southerly direction only;
- (c) Ethel Street, between Western Main Road and Bay Road, in a southerly direction only;
- (d) Bournes Road, between Western Main Road and Church Street, in a northerly direction only;
- (e) Brunton Road, between Western Main Road and Church Street, in a northerly direction only;
- (f) Mooneram Street, between Western Main Road and Church Street, in a northerly direction only;

- (g) Bombay Street, between Western Main Road and Church Street, in a northerly direction only;
- (h) Clarence Street, between Western Main Road and Anderson Street, in a southerly direction only;
- (i) Vidale Street, between Western Main Road and Anderson Street, in a southerly direction only;
- (j) Dengue Street, between Western Main Road and Anderson Street, in a southerly direction only.

Parking  
prohibited

4. On the dates and during the times specified in paragraph 2, parking is prohibited on—

- (a) Western Main Road, between Fort George Road and Tragarete Road;
- (b) Quamina Street, between Brunton Road and Bournes Road;
- (c) Mathura Street, between Western Main Road and Carlton Avenue;
- (d) Serpentine Road;
- (e) Mary Street;
- (f) Hayes Street, between Mary Street and Serpentine Road;
- (g) Clarence Street; and
- (h) Agra Street, between Western Main Road and Madras Street.

Traffic  
prohibited

5. Vehicular traffic is prohibited on the Western Main Road, between Long Circular Road and George Cabral Street.

Removal and  
impounding  
of vehicles  
unlawfully  
parked

6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
