MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(INDEPENDENCE DAY PARADE, TOBAGO) ORDER, 2017

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Independence Day Parade, Tobago) Order, 2017.
2. This Order shall have effect from 7.00 a.m. to 11.00 a.m. on Duration Thursday 31st August, 2017.
3. Drivers of motor vehicles shall not drive or park on—

Vehicular
traffic and
parking
prohibited

 - (a) Claude Noel Highway, between the junction of Wilson Road and Claude Noel Highway and the junction of the Claude Noel Highway and Windward Road, Bacolet;
 - (b) Claude Noel Highway and Friendsfield Road Junction to Calder Hall, phase one; and
 - (c) Darrel Spring Road and Wilson Road onto the Claude Noel Highway.
4. Drivers of motor vehicles shall not park on—

Parking
prohibited

 - (a) Wilson Road, between Claude Noel Highway and Milford Road;
 - (b) Post Office Street;
 - (c) Garden Side Street, between Darrell Spring Road and Carrington Street;
 - (d) Bacolet Street; and
 - (e) Carrington Street.
5. The following public Car Parks will be closed from 6.00 p.m. on Car Parks Wednesday 30th August, 2017 to 11.00 a.m. on Thursday 31st August, closed 2017:
 - (a) Garden Side Street;
 - (b) Market Square; and
 - (c) NIB Mall.

| Traffic routes | <p>7. Drivers of motor vehicles entering and exiting Scarborough—</p> <p style="margin-left: 40px;">(a) from east to west, shall turn onto Windward Road, Bacolet and continue along the road into Scarborough;</p> <p style="margin-left: 40px;">(b) from west to east, shall turn south onto Orange Hill Road to proceed into Scarborough;</p> <p style="margin-left: 40px;">(c) from west to east intending to turn north onto Wilson/Plymouth Road shall do so and continue north;</p> <p style="margin-left: 40px;">(d) from the northside road shall proceed straight across the Highway into Scarborough;</p> <p style="margin-left: 40px;">(e) from Calder Hall Road shall travel straight proceeding north and south respectively;</p> <p style="margin-left: 40px;">(f) to proceed to the eastern side of Tobago shall proceed east along Carrington Street, onto Burnette Street, east along Main Street and south along Bacolet Street to the Claude Noel Highway and turn east along the Claude Noel Highway; and</p> <p style="margin-left: 40px;">(g) to proceed to the western side of Tobago shall proceed west along Carrington Street, continuing west along Milford Road, north along Orange Hill Road to the Crusoe By Pass or Claude Noel Highway and continue west.</p> |

routes | <p>9. Drivers of emergency vehicles shall proceed north along North Side Connector Road to the Rockley Vale traffic light and west along the Claude Noel Highway and north along the Signal Hill Patience Hill Road to the Scarborough General Hospital.</p> |
| Removal and
impounding
of vehicles
unlawfully
parked | <p>10. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by a member of the Police Service and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.</p> |
