ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE  
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)  
(POINT FORTIN BOROUGH DAY CELEBRATIONS) ORDER, 1995

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Point Fortin Borough Day Celebrations) Order, 1995.

2. This Order has effect between the hours of 10.00 a.m. on Saturday, 6th May, 1995 and 2.00 a.m. on Sunday, 7th May, 1995.

3. No person shall park a vehicle on—

- (a) Reid Road;
- (b) Guapo-Cap-de-Ville Road, between Bryce Road and Point Ligoure Road;
- (c) Point Ligoure Road;
- (d) Millette Street;
- (e) Point Fortin Main Road, between Eagle Hall Street and Tank Farm Street;
- (f) Tank Farm Street, between Point Fortin Main Road and Guapo-Cap-de-Ville Road;
- (g) Clifton Hill Road;
- (h) Canaan Road;
- (i) Sergeant Street, between Techier Road and Modeste Street; and
- (j) Techier Main Road.

Parking prohibited

4. (1) Motorists approaching Point Fortin from the east shall proceed west into Reid Road and into Guapo-Cap-de-Ville Road.

Traffic routes

(2) Motorists approaching Point Fortin from the south-west along Guapo-Cap-de-Ville Road shall proceed north along Point Ligoure Road, east into Millette Street, north into Point Fortin Main Road, north-east into Tank Farm Street, north into Guapo-Cap-de-Ville Road, east into Clifton Hill Road and Richardson Street, south into Canaan Road, west into Sergeant Street and south-west into Techier Road.

5. Vehicular traffic is prohibited on the following roads:

Roads closed

- (a) Bryce Road, between Guapo-Cap-de-Ville Road and Wickham Street;
- (b) Wickham Street, between Bryce Road and Point Fortin Main Road;
- (c) Guapo-Cap-de-Ville Road, between Bryce Road and Tank Farm Road;

- (d) Point Fortin Main Road, between Wickham Street and Reid Road;
- (e) Richardson Street, between Guapo-Cap-de-Ville Road and Adventure Road;
- (f) Adventure Road, between Richardson Street and Frisco Junction; and
- (g) Techier Main Road, between Adventure Road and Sergeant Street.

6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order, may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
