ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (SIPARIA FETE) ORDER, 1995

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Siparia Fete) Order, 1995.

2. This Order comes into effect at 8.00 p.m. on Saturday, 6th May, 1995 and ceases at 12.00 midnight on Sunday, 7th May, 1995. Commencement and cessation

3. Parking is prohibited on the following roads: Parking prohibited
(a) Grell Street;
(b) Gambal Street;
(c) Siparia Road, between High Street and Gambal Street;
(d) Victoria Street, between Allies Street and La Pastora Street;
(e) Allies Street, between Bermudez Trace and Victoria Street;
(f) La Pastora Street;
(g) De Gannes Lane; and
(h) Bermudez Trace.

4. Between the hours of 8.00 p.m. on Saturday, 6th May, 1995 and 12.00 midnight on Sunday, 7th May, 1995 vehicular traffic is prohibited on the following roads: Roads closed

- (a) Allies Street, between High Street and Bermudez Trace;
- (b) Daisy Voisin Street, between High Street and Victoria Street;
- (c) Coora Road, between High Street and Victoria Street;
- (d) Edward Street;
- (e) High Street, between Grell Street and La Pastora Street;
- (f) George Street;
- (g) Mary Street; and
- (h) Station Street, between Victoria Street and Mary Street.

5. On Sunday, 7th May, 1995 between the hours of 9.00 a.m. and 1.00 p.m. vehicular traffic is prohibited on La Pastora Street. Road closed

6. (1) Motorists entering Siparia from the east, shall proceed by way of Grell Street, Gambal Street and Siparia Road. Entry into and exit from Siparia

(2) Motorists leaving Siparia in an easterly direction, shall proceed by way of Grell Street, Gambal Street and Siparia Road.

Diversion of traffic

7. (1) Motorists approaching Siparia from Mendez Village along Coora Road and proceeding to San Fernando, shall be diverted east into Victoria Street, into Allies Street, into Bermudez Trace, and east into the Siparia-Erin Road.

(2) Motorists approaching Siparia from Mendez Village along Coora Road and proceeding to Erin, shall be diverted west into Victoria Street, then into Station Street and west into Siparia-Erin Road.

Removal and impounding of vehicles unlawfully parked

8. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
